**Trial Bath Supports Agreement: Important information.** Please read the following and sign and return the enclosed copy to us. We will then be able to process your request.

If you work within an organisation (eg Social Services/NHS) that uses a formal order number system, please provide us with an **official order** accepting the terms below before we can proceed.

Kingkraft are able to provide a loan supports service on the following conditions:

The supports are provided to you from our used loan stock. They have been pre-used but have been carefully cleaned and prepared for dispatch. However Kingkraft can accept no liability for the condition in which they are received by you.

When they are received, please check them carefully for damage or contamination which may have occurred during shipment. In case of doubt, do not use the support and contact Kingkraft for advice on the number shown.

The supports are intended for use in assisted bathing. The bather should never be left unattended when using the supports. User instructions are included with the supports and these should be followed carefully. If for any reason the instructions are missing, do not use the support but contact Kingkraft for a copy relevant to your support. Particular care should be paid to securing the support in the bath especially with a lightweight bather as there is a natural buoyancy which will cause the support to float causing risk of injury or drowning.

The supports are loaned to you on a trial basis for a period of 14 days from the date of shipment. A proforma invoice is included with the supports. If the supports are returned to Kingkraft within the 14 day period (return instructions are enclosed with the support) no charges will be applicable. If the support is not returned or it is returned in a damaged or soiled condition, the full cost shown on the invoice will be charged by Kingkraft and the matter passed to our credit recovery department.

(Please remember that it is not permitted to send bio hazardous material through the post. The support must be rigorously cleaned and disinfected by you in accordance with the instructions in order to ensure there is no hazard to anyone handling the package on its return).
